Time is running out...

CAZ will come into effect from 8th April 2019, starting in London with an Ultra-Low Emission Zone (ULEZ).

There are 5 confirmed charging zones that will be implemented between 2019-2022, and 12 potential future zones identified.

Fleets operating in London Clean Air Zones are unprepared for these new changes

55.3% of vehicles that entered the London CAZ zone between August 2017 and August 2018 were non-compliant. This would have resulted in total fines of £1690 per vehicle for that period, had the new regulations been in place.



Birmingham and Sheffield fleets are also at risk...

53.2% of vehicles operating in the Birmingham ULEZ zone were non-compliant, facing a potential fine risk of £711 per vehicle between August 2017 and August 2018.

of cars, vans and motorbikes are **NON-COMPLIANT**

44.4%

of HGVs are **NON-COMPLIANT**

53.4% of vehicles operating in the Sheffield CAZ zone were also non-compliant, facing a potential fine risk of £2476 per vehicle over that same period.
